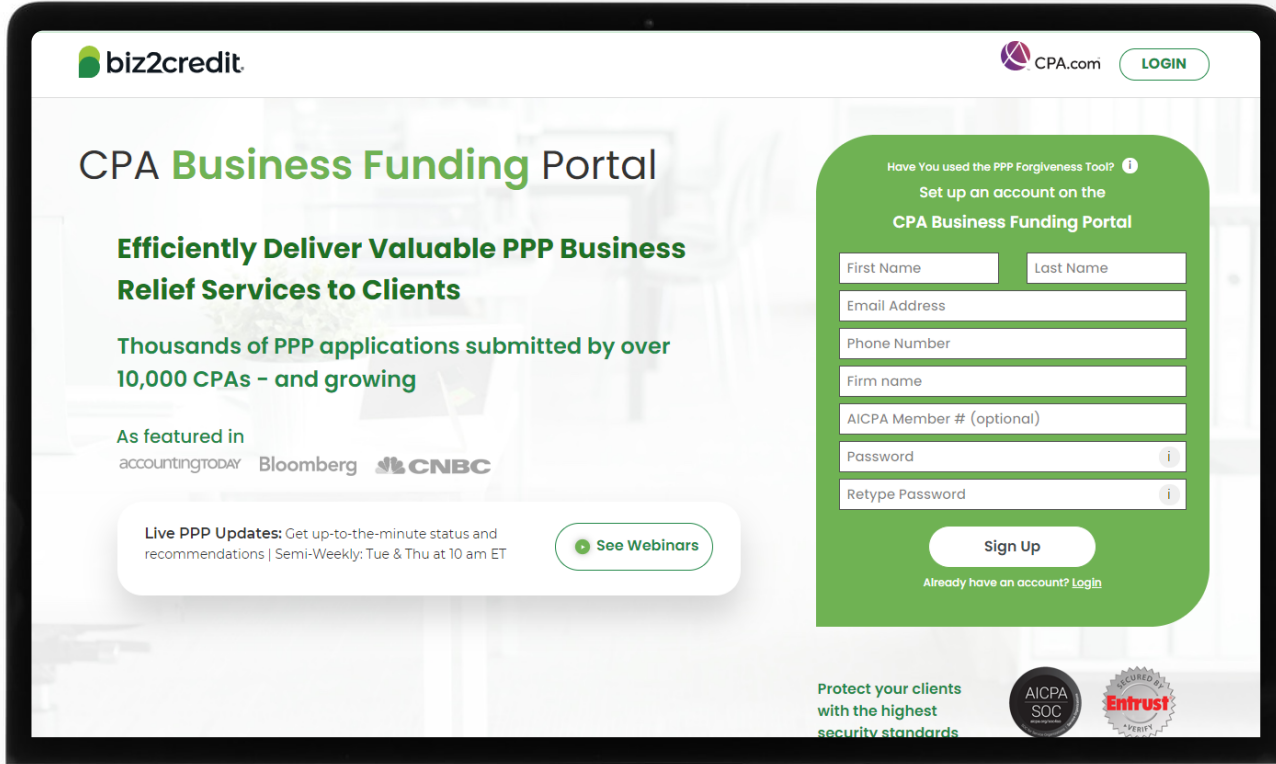

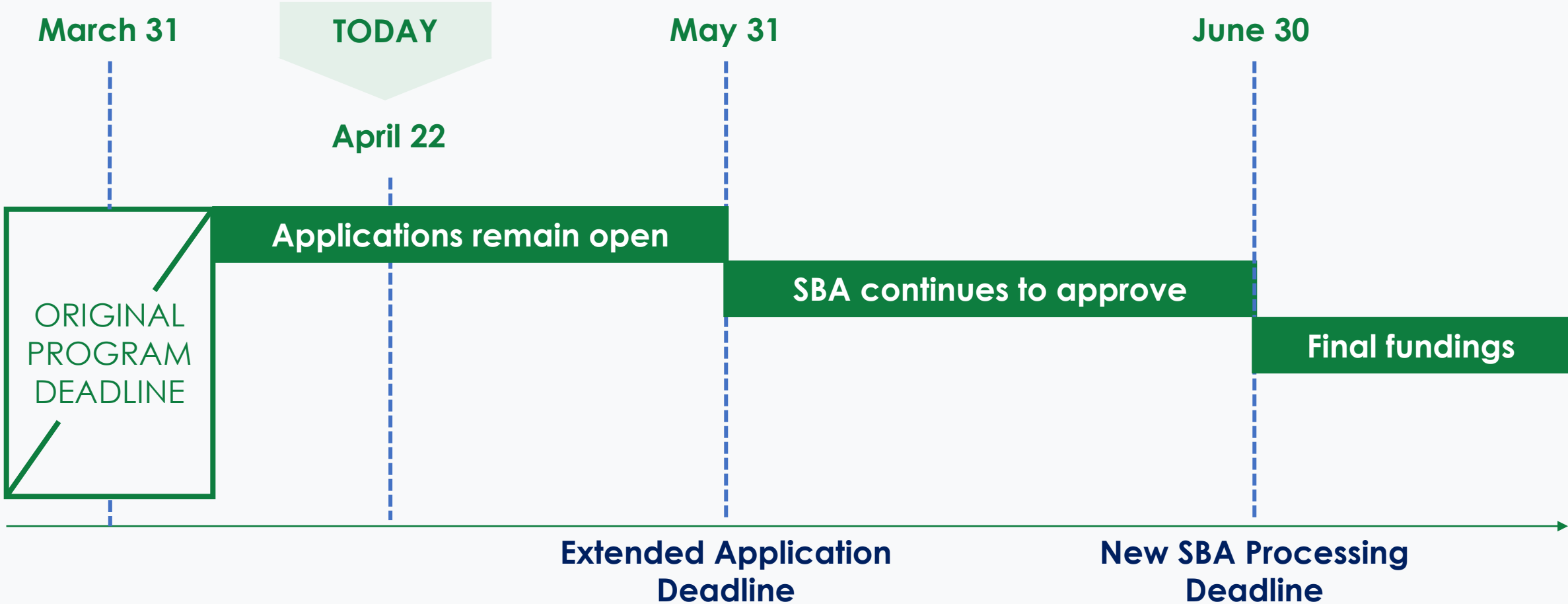


PPP Timeline: Looking Ahead

Upcoming Forgiveness Journey Updates

As more funded PPP Loans are now eligible for loan forgiveness (8-week minimum covered period), we are opening forgiveness applications for these loans. There is unique PPP forgiveness functionality being developed specifically for loans that were funded through the CPA Business Funding Portal during this round.

Note: SBA Form 3508, 3508EZ, 3508S, as applicable, will be sent to the email address auto populated in the Principal's email address field by default. You can edit the email address here and the email will go the updated one. Only the first Principal on the application will receive the email for eSignature.

You can also prepare forgiveness applications for loans that were not funded on the Portal.

Guiding Independent Contractors

For borrowers that obtain income from 'gig' work or who serve as an independent contractor qualifying for 1099 reported wages, the best option for firms to support these applications is to upload the full 1099-MISC or 1099-NEC that the borrower received for tax year 2019 or 2020 (depending on the reference period being used).

New for Tax Year 2020, the non-employee compensation form is used to report wages that were earned from so-called gig working contracts with companies such as Uber, Lyft, Doordash, TaskRabbit and Upwork that report contractor wages to the IRS.
